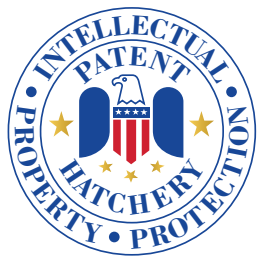

• **Paul Nechkin**

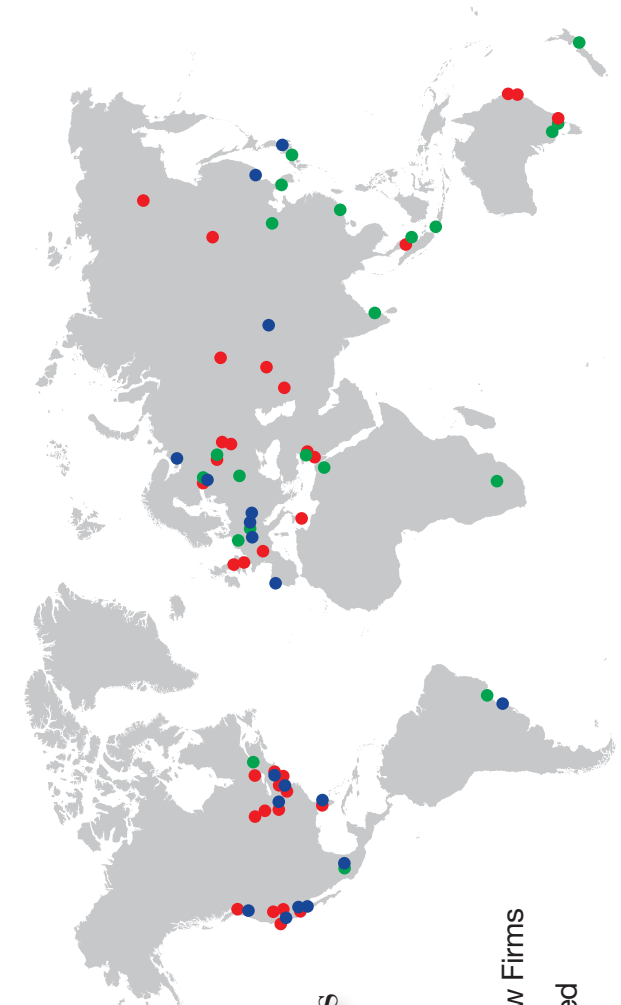
